Subject: Quality Monitoring System for works undertaken from Central Road Fund

Sir,

Rule 9 (1) of Central Road Fund (State Roads) Rules, 2014 inter-alia provides that project monitoring and quality control of the works shall be done at regular interval in methodical manner by adopting the following procedure:-

(a) there should be a quality monitoring system at the State Level or Union territory level, consisting of such experts and supporting staff as may be appointed by the State Government or Union Territory, as the case may be;

(b) the quality monitoring system referred above shall devise a Quality Assurance (QA) System delineating the requirements of quality, the responsibility of the officers and contractors, conduct independent tests, and examine QA documentation to spot non-conformities and shall have the responsibility of training of PWD staff and recommending laboratory and field testing facilities.

2. In view of above, it is requested to submit the details of quality monitoring system prevailing in the States/ UTs for quality assurance in the execution of CRF/EI/ISC projects elaborating each aspect mentioned in para-1 above. Further, it is requested to submit the complete details of laboratory facilities available with States/UTs for testing along with SOP for its utilisation. The details of engaging third party quality auditors by States/UTs may also be intimated.

3. As per CRF Rules Central Government has also to evolve a mechanism to ensure quality of works taken under CRF. The RO MORTH stationed at respective states are supposed to be involved to ensure the quality of CRF works along with NH(O) works. In this regard, it is also requested to furnish the documents for action taken by your office towards quality assurance and inspections carried out of the CRF works. The details of engaging third party quality auditors or conducting quality tests through third party laboratories by your office may also be intimated. The above details may be submitted positively by 17.06.2019.
